In determining a contractors' qualifications for NATO SOFA status, a Major Certification is viewed as equivalent to an Associate's Degree.

1) Criterion for recognition as a Major Certification:

- Widely Recognized
- Independently Administered
- Difficult to Obtain

2) DOCPER will consider certifications that are not identified above:

- by utilizing the Department of Labor (DOL) sponsored site “Career One Stop” to ascertain if the certification meets the 3 criteria listed above:
- Search the certification at:

- Certification that qualifies should display “More than two years of education or training after high school required?” **“Yes”**
- If the certification description is: widely recognized; independently administered; and difficult to obtain; then it can be reviewed for consideration as a Major Certification by DOCPER
- Contracting Officer Representatives (CORs) may submit Major Certification consideration requests, to DOCPER, on a case-by-case basis
- Contractor Applicants may be required to provide proof of certification

3) Baseline certifications required for the IA Workforce:

- are documented in the Extension of Appendix 3 to DoD 8570.01- Manual

- Level III certs held by CSSP personnel are considered, by DOCPER, as equivalent to an AA degree
